Applications may take up to 45 days to be reviewed before a decision is given. All improvements to the exterior or additions structurally and work that requires a licensed contractor, and a building permit issued by the Osceola County Building Office. <u>You must email</u> <u>permitting@OSCEOLA.ORG verifying if a permit is required or not and attach their response to this</u> <u>application. This is not the responsibility of the POA or the ARC Committee to confirm permits.</u>
